## WHAT WE BELIEVE AND WHAT WE DO

The Military Law Task Force is a standing project of the National Lawyers Guild. It includes attorneys, legal workers, law students and "barracks lawyers" interested in military, veterans and draft issues.

Our roots go back to the NLG's military law project of the late 1960's and the publication of *On Watch* (a military law journal) beginning in the 1970's.

The MLTF believes that the armed forces in the United States are used to carry out immoral interventionist foreign policy. That the U.S. military disregards the democratic and human rights of its own personnel as it seeks to maintain global dominance.

The Task Force assists lawyers, GI rights counselors, veterans and community activists opposing military policy. We provide support, mentorship and continuing education to MLTF members as well as to servicemembers directly. Many of our resources are available free of charge on our web site.

The Task Force's activities include:

- trains and mentors legal workers, counselors and beginning military law attorneys in all aspects of military law via CLEs, workshops, training materials and direct communication
- sponsors seminars and workshops on the latest policy and regulations and other aspects of military and veteran's law, produces educational materials on these issues, and provides support for members on particular cases or projects
- publishes a quarterly newsletter, *On Watch*, hosts a listserv on legal and political issues for Task Force members, and maintains a website (www.nlgmltf.org), a Facebook page and Twitter feed
- provides direct assistance to servicemembers, particularly around our priority areas, as well as AWOLs and discharges
- organizes legal and advocacy resources in the support of our program priorities, including GI resistance
- · publishes thoughtful, accurate and relevant resources on military law that reflect our political perspective
- provides support to/partners with other groups in the pursuit of our mission


